Statements like these from program participant Derrick ground us and motivate the team to deepen our efforts even while we celebrate a hallmark year in 2018.

Last year the Center for Housing and Health (CHH) served more people than ever before, led a County-wide Strategic Plan integrating housing and health care, launched a new website, and established relationships with two major hospital systems. We demonstrated significant decreases in unnecessary health care use and reduced cost in the Better Health

though Housing hospital projects that drew national media attention. These projects also laid the foundation for CHH to win a contract for an innovative new program, the Flexible Housing Pool (see the What's New section for more information).

Since CHH received its first grant of \$100,000 in 2011, the organization has grown to a budget of over \$5 million this year. CHH and the AIDS Foundation of Chicago (AFC) both continue to benefit from their unique subsidiary relationship with CHH relying on the strength of AFC's infrastructure and AFC expanding

As we look back on the year, a thank you is due to our funders who provide crucial support and our partner organizations who make our work possible day in and day out. We also need to thank our program participants who embody resilience and serve as a reminder that our work is not done until every one of our neighbors can claim their right to a safe home and quality health care.

Although Daniel changed his relationship with drugs years ago, the effects were still taking a toll on his body and he was told that he needed surgery or else he would risk losing mobility in his legs. However, Daniel was now out of a job as a busboy, so his focus was set on securing a steady income. He applied for Social Security benefits, but was denied and eventually ended up living on the streets for 7 months because he could not afford a place to live. He was later charged with retail theft, but luckily, the judge in Daniel's case recognized that he would benefit more from a rehabilitation program, rather than jail time.

Once in the program, Daniel's case manager connected him to CHH's SOAR coordinator who helped him successfully apply for and win his case for social security benefits. With a secure income and a steady place to live, Daniel was finally able to focus on taking care of his health and triumphantly underwent two hip replacement surgeries. Now, Daniel has plans to become a counselor in order to give back to his community and is thankful for those who supported him to get to where he is today.

OUR WORK

PERMANENT SUPPORTIVE HOUSING



270 HOUSEHOLDS 47 FAMILIES AND 77 CHILDREN

We offered permanent supportive housing, including intensive wraparound case management services, to 270 households, including 47 families and 77 children.



165 PARTICIPANTS

165 participants in our permanent supportive housing program achieved increased or stable income.



245 participating households were stably housed for 12 months or longer in 2018.

DIRECT CLIENT SERVICES



17 CASE MANAGERS 9 PARTNER AGENCIES

We worked with 17 case managers from 9 partner agencies to provide direct services to participants throughout the Chicagoland area.



15 FAMILIES

We delivered furniture sets and essential move-in items to 15 families and individuals after they moved into their apartments.



We worked with 37 participants to help them apply for disability benefits in order to obtain a steady income.

SYSTEM LEADERSHIP



We coordinated the work of over 200 Skilled Assessors from more than 70 agencies throughout Chicago to ensure that all people experiencing homelessness are assessed for housing resources in the Coordinated Entry System.



We convened the regional H2 Strategic Plan with leaders in health care, housing, community, government and philanthropy. The H2 Plan completed a data sharing project between the homeless system and academic medical centers to investigate identification of homelessness and patterns of health care utilization.



850 SUPPORTIVE HOUSING RESIDENTS

We guided the Supportive Housing: Optimizing Placements research study of over 850 supportive housing residents in partnership with the Medical College of Wisconsin and the AIDS Foundation of Chicago. In 2018 the study completed all resident interviews and achieved a retention rate of nearly 90% for study participants.



4 HOSPITALS AND 26 PARTNER AGENCIES 91 PEOPLE

We led the Better Health through Housing Collaborative, comprised of 4 hospitals and 26 partner agencies, that has housed 91 people throughout Chicago since its inception.



In 2019, CHH will launch a new County-wide Supportive Housing program model called the Flexible Housing Pool (FHP) to house homeless individuals with poorly-managed chronic health conditions. The FHP uses an integrated housing, health and social services design. It combines multiple public and private investments into one pool that will provide rental subsidies and services funding as a payer of last resort. The goal of the project is to promote cross-sector investment in a housing and service delivery strategy that will dramatically increase supportive housing for people impacted by homelessness with complex health needs and a history of justice involvement.

In its first phase, the FHP will offer housing and support to at least 50 frequent utilizers of Cook County Health.
